PTCC is excited to announce the availability of Coronavirus Response and Relief Supplemental Appropriations Act(CRRSAA) emergency funds. The CRRSAA emergency funds are being awarded based upon financial need, with the first allocation of funds going to students eligible for the Federal Pell Grant.
